NEW BUSINESS

Mayor Webb raised the topic of subsequent City Council meetings in the month of May. A Special Meeting will be held on May 19th, 2020 at 6:00 p.m. for the purpose of processing applications for Marihuana licensure. The Regular Meeting scheduled for May 26th, 2020, will also be held via *Zoom*.

Councilmember LeCureaux proposed adding a Hazel Park School Board Member to the Hazel Park Historical Commission.

COMMUNICATIONS FROM DEPARTMENT HEADS

Councilmember McFall raised the issue of semi-trucks frequently traversing residential streets because of the I-75 construction.

COMMUNICATIONS FROM CITY ATTORNEY - None

COMMUNICATIONS FROM CITY MANAGER

City Manager Klobucher stressed that Michigan's system of municipal finance is fundamentally broken. COVID-19 is going to leave a long trail of economic misery and destruction in its wake. The virus will have a tremendous effect on the City of Hazel Park due to an imminent revenue-sharing reduction from the State of Michigan given the drop in sales tax consequent to the social-distancing shutdown. A federal stimulus package for units of government is a hope but is by no means a guarantee of funding. Absent additional funding via a stimulus package, this crisis will likely be as bad as the Great Recession. The City's FY 2020-21 Budget will require amendment as the full economic impact of COVID-19 unfolds.

COMMUNICATIONS FROM MAYOR & COUNCIL

Councilmember McFall advised that every Monday and Friday the YMCA distributes food in the Recreation Center parking lot (620 W. Woodward Heights Blvd.) from 4:30 p.m. to 5:00 p.m. A fund has been started through Main Street Oakland County for Hazel Park businesses impacted by the State shutdown, with \$6500 raised so far not including a match of \$4000 from the County.

Councilmember Aubry thanked Council for passing the Proclamation for Gun Violence Awareness Day. The number of COVID-19 cases in Michigan is thankfully beginning to stabilize, though that does not mean we are out of danger yet. The more cooperative we are, the more quickly we can start to reopen and find a new normal. State Senator Jeremy Moss and State Representative Robert Wittenberg are great resources for help with unemployment assistance. She also encouraged people to support small businesses with curbside pickup when possible.

Councilmember McFall added that May is Williams Syndrome Awareness Month. More information is available at Williams-syndrome.org.

City Manager Klobucher reiterated the importance of supporting our local businesses, not least of all because the tax structure in the State of Michigan is based almost entirely on brick-and-mortar businesses. If they fail, it will depress the city's property values and negatively impact quality of life.

Councilmember LeCureaux inquired about a Resolution advocating financial relief for municipalities and encouraged people to support local restaurants during this challenging time. City Manager Klobucher thanked Councilmember LeCureaux for his volunteer work at the rapid-test center.

Mayor Pro Tem Sullivan appreciated everyone's participation in this new meeting method. She thanked City Attorney Schwartz and Animal Control Officer Jennifer Thomas for their work on overhauling the Animal Control Ordinance. Additionally, there is an "Honoring our Heroes" Facebook page to virtually and interactively celebrate Memorial Day using photos, given that the normal festivities have been cancelled. Local food pantry options are available online via the City and its Councilmembers. Those having difficulty with their unemployment benefits should consult an informative Facebook Chat hosted by State Senator Moss.

Mayor Webb wished a belated happy Mother's Day to all mothers. County grants are available for local businesses, a few of whom in Hazel Park have already taken advantage of this program. As a small business owner, he understands how difficult times are and how the utmost caution is required from everyone.
