AN ORDINANCE TO AMEND CHAPTER 2.48.020 Composition - Vacancy of Chapter 2.48 of the Hazel Park Municipal Code - Historical Commission

THE CITY OF HAZEL PARK ORDAINS:

PART I AMENDMENT.

2.48.020 - Composition—Vacancy.

This Ordinance hereby amends Chapter 2.48.020- Composition-Vacancy of Chapter 2.48 of the Hazel Park Municipal Code – Historical Commission to add a member of the Hazel Park School Board or designee and reads as follows:

The Hazel Park Historical Commission shall be composed of an indefinite number of members, but not less than five, appointed by the mayor with the concurrence of city council for two-year terms. One member of the Hazel Park Historical Commission shall be reserved for a member of the Hazel Park Board of Education or a representative of the Hazel Park School District subject to approval by City Council. Vacancies occurring other than by expiration of term may be filled for the unexpired portion of the term in the same manner as original appointments. Members may be removed by the majority vote of the city council when it is deemed in the best interest of the historical commission and the city.

PART II. SAVING CLAUSE.

The amendment of Chapter 2.48.020 Composition-Vacancy of Chapter 2.48 of the Hazel Park Municipal Code – Historical Commission does not affect or impair any act done, offense committed, or right accruing or accrued or liability, penalty, forfeiture, or punishment, pending or incurred to these amendments.

PART III. REPEAL.

This ordinance hereby repeals any ordinance which conflicts with the provisions hereof.

PART IV. EFFECTIVE DATE; PUBLICATION.

The provisions of this ordinance shall become effective ten days after its publication and shall be published within ten days of its adoption by publication of a brief notice in the newspaper circulated in the city stating the date of the enactment and the effective date of the ordinance, a brief statement as to the subject matter of this ordinance and such other facts as the Clerk deems pertinent, and that a copy of the ordinance is available for purchase and/or inspection at the office of the City Clerk.


