

JUNK COLLECTOR LICENSE CITY OF HAZEL PARK



This application must be accompanied by the following documents: 1) COPY OF APPLICANT'S DRIVER'S LICENSE, 2) COPY OF VEHICLE REGISTRATION, and 3) COPY OF PROOF OF INSURANCE.

- The application fee for a Junk Collector License is \$100.00. If issued, the license is valid until April 30th.
- Junk collecting is NOT permissible between the hours of 7:00 p.m. and 7:00 a.m., or at any time on Sunday.
- No junk collector shall attempt to remove refuse or recyclables in containers or bags, remove or attempt to remove any recyclables not in containers whether on public or private property, pursuant to HPMC Ch. 8.29 (*i.e., recycling containers and garbage cans CANNOT be collected from or otherwise disturbed*).
- No junk collector licensed under the provisions of this chapter shall purchase any junk, goods, article, or anything whatsoever from any minor under eighteen (18) years of age without the written consent of the parent or guardian of such minor specifically designated.
- One license per collector, per vehicle and/or trailer (any individuals who are assisting in collection shall be listed on this application). Licenses shall not be used by any person or vehicle other than named on the license.
- If the licensee is found to be in violation of any of the rules or regulations pursuant to HPMC Ch. 5.39, or any other Ordinances or laws, this license may be revoked. Additionally, this license may be revoked by the Hazel Park Police Dept. at any time.
- While collecting, you must be in possession of this license (along with Driver's License, Vehicle Registration and Proof of Insurance) at all times. It must be prominently displayed on the dashboard of the vehicle, and the licensee must present it to any police officer or citizen who requests to see it.
