ORDINANCE NO. 06-21

**AN AMENDMENT TO ORDINANCE TO TITLE 5, BUSINESS LICENSES AND
REGULATION, CHAPTER 5.04, COMMERCIAL MARIHUANA FACILITIES,
SECTION 5.04.050, ENTITLED APPLICATION AND FEE REQUIREMENTS**

THE CITY OF HAZEL PARK ORDAINS:

PART I. AMENDMENT.

Section 5.04.050 – Application and fee requirements

D. Applications shall include the following non-refundable fees:

1. Each initial and renewal application submitted to the city requesting to operate a facility within the city shall pay to the city a non-refundable annual fee in the amount of five thousand (\$5,000) dollars per license to help defray administrative and enforcement costs associated with the operation of a marihuana facility in the city.
2. Each initial application submitted to the city requesting to operate a facility within the city shall pay to the city a non-refundable application fee of five thousand (\$5,000) dollars per license.
3. Upon approval of a city operating license and before the license will be issued by the city, and at the time of renewal, each licensee shall pay to the city a nonrefundable annual inspection fee of four thousand (\$4,000) dollars to defray the cost of city inspections.
 - i. All facilities shall be inspected by the city on at least a quarterly basis to ensure compliance and that appropriate electrical, fire safety, plumbing, filtration, and waste disposal systems are installed and in proper working order.
 - ii. In addition to the foregoing annual inspections, the city may inspect any facility, at any time, upon reasonable cause to believe that a violation of the City of Hazel Park ordinances, the acts, or State of Michigan administrative rules has occurred.

PART II. SAVING CLAUSE.

The amendment of Title V, BUSINESS LICENSES AND REGULATIONS, Chapter 5.07, Use of City Seal and Flag, Section 5.07.010 through Section 5.07.060, and does not affect or impair any act done, offense committed, or right accruing or accrued or liability, penalty, forfeiture, or punishment, pending or incurred to these amendments.


PART III. REPEAL.

This ordinance hereby repeals any ordinance which conflicts with the provisions hereof.


PART IV. EFFECTIVE DATE; PUBLICATION.
