City Manager Klobucher thanked Council for unanimously approving the budget and Finance Director Christiansen for her Herculean effort on it. Four major road projects, two major economic developments, Master & Recreation Plan revisions, medical and recreational marihuana considerations, negotiations with seven labor unions, forensic accounting, the construction of 30 new homes, the Scout Park project, Memorial Day festival, and new Michigan Indigent Defense Commission budget requirements have all required attention this year.

City Manager Klobucher wished City Attorney Schwartz good luck regarding an upcoming medical procedure for a loved one. While not necessarily the most difficult period in his tenure as City Manager, the year to date has proved the busiest. Additionally, Michigan's system of municipal finance is fundamentally broken.

COMMUNICATIONS FROM MAYOR & COUNCIL

Councilmember Sullivan wished everyone a safe, happy Memorial Day.

Councilmember LeCureaux advised everyone to come out for the Memorial Day festivities, as well as to watch out for cyclists.

City Manager Klobucher stated that the City of Ferndale will suspend road construction for affected areas of Hazel Park during the Memorial Day celebration. He also thanked Mayor Pro Tem Aubry for assistance with road projects.

Mayor Pro Tem Aubry requested an additional bicycle rack at Green Acres Park for Memorial Day.

Councilmember Holland noted that the construction on south John R Rd. has started, which although it brings noise and chaos is nonetheless nice to see.

Mayor Webb, a longtime proponent for a road dieting, has recently been told by business owners that they are excited for the south John R Rd. project. Additionally, citizens should be aware of light and sirens, as exemplified by the recent instance of a Hazel Park police car being struck and severely damaged by an accident with a civilian vehicle. Hopefully the road diet will also benefit emergency vehicles due to the new center lane.
